MEMBERSHIP CATEGORIES

Seven Day Membership

May play every day with the exception of Men on Tuesday and Thursday mornings during Women's competitions, and Women during Monday (PM) and Wednesday Men's competitions.

Six Day Membership

May play on Sundays and weekdays with the exception of Men on Tuesday and Thursday mornings during Women's competitions, and Women during Monday (PM) and Wednesday Men's competitions.

Intermediate Membership (Age 25 – 39)

All intermediate categories are entitled to the same playing rights as a Seven Day member. See above.

Restricted Membership

May play Sundays to Fridays, except for Tuesday Women's competitions. Restricted members are entitled to 6 rounds of golf for free per year.

All rounds after the initial 6 rounds will attract the member's guest fee (currently \$60 for 18 holes – no competition fee will be applied) – including Sunday mixed events etc – the maximum number of paid rounds in any year will be 24.

Junior Membership

Juniors are from the age of 12-24 years old and are entitled to the same playing rights as a Seven Day member.

Social/Non-Playing and Neighbourhood Members

Social / Non-Playing are those members who, in their own right, can only use the facilities of the Clubhouse.

Neighbourhood members may use the facilities of the Clubhouse and are eligible to play in Nine and Dine events for a member fee of \$30 and introduce guests for a \$40 fee each. Bookings must be made via the Golf Centre.

FEE STRUCTURE

Entrance Fee: An Entrance Fee of \$5995 is payable (instalment options are available and attract a \$205 admin fee) by new members and applies to all membership categories, with the exception of the following current offers:

Intermediate Membership: An Entrance Fee of \$3300 (instalment options are available and attract a \$205 admin fee).

Family Member: An Entrance Fee of \$3300 (instalment options are available and attract a \$205 admin fee). A family member is defined as a mother, father, grandfather, son, daughter, grandson, granddaughter, spouse or partner, brother, sister, nephew or niece. Family Membership is only for those who are related to current Green Acres members.

Junior Membership: Junior Members are those under the age of 25 years old. The Entrance Fee is \$1800 (instalment options are available and attract a \$205 admin fee).

Previous Yarra Members: An Entrance Fee of \$4495 (instalment options are available and attract a \$205 admin fee).

Subscription Fees: Please see the table below for the 2017/2018 Subscription Fees.

Clubhouse Levy: The clubhouse levy is payable annually until 2020.

- 3. If the applicant does not know a current Green Acres member to act as a Proposer, the Referee Form must be completed by a person who can vouch for the applicant's good standing.
- 4. Once all forms are complete please return to the office.

 Please be advised that it is the responsibility of the applicant and/or proposer to ensure that these membership papers are all complete and returned to the Club office.
- 5. Subject to approval by the Membership Sub-Committee the applicant and proposer will then be requested to attend a membership induction with members of the Committee. The purpose of the induction is to:
 - Familiarise the new member on the operations of the Club
 - Ensure that the future member feels welcome and has a smooth transition to membership of Green Acres Golf Club.
- 6. At the induction the applicant will receive a letter of offer, along with an invoice for the payment of entrance and annual fees.

PAYMENT IN FULL

We accept Entrance Fee and Annual Subscription payments in full by: Cash, Cheque (made payable to Green Acres Golf Club), Mastercard, Visa or AMEX (credit card payments attract a surcharge), BPAY or Direct Deposit (see bottom of your invoice for bank details). EFT payments can be made in person at the Club office.

PAYMENT BY INSTALMENTS

Entrance Fee (incurs a \$205 administration fee):

We accept payment of the entrance fee in instalments. After payment of the first Entrance Fee instalment, the balance of instalment payments are billed 1 April each year until fully paid. Please refer to your membership agreement.

Annual Subscription (Pay by Instalment Plan):

Green Acres Golf Club offers an instalment option to 7 and 6 day members for the payment of the annual subscription via direct debit. (Please note this option is only available at the beginning of the club's financial year). Instalments will be over 9 months and will include an annual account keeping fee.

PRIVACY POLICY

The Board of Directors of the Green Acres Golf Club is committed to the protection of personal information of members. The Club is subject to the national Privacy Principles under the Privacy Act. The National Privacy Principles govern the way the Club will collect, use, disclose and secure information about members. They also permit the member to access the information the Club holds about that member in order to correct or update it. Member information is required to run the business of the Club.

- The Club may collect and hold information such as the member's name, age, address, contact details, gender, employment, next of kin and other information relevant to Club membership.
- Information collected will be used principally for the purpose of managing the affairs of the Club and helping members maximise the benefits of membership. This may include providing members with information about services and facilities at the Club including events, functions and other Club activities. Any sensitive information, such as health information, or the use of electric carts on the golf course, may be collected as required to comply with the rules of the Club.
- The Club has, and will continue to have, data quality procedures in place to check that personal information about members is accurate, complete and up to date and will aim to ensure that information is held securely at all times.
- Members have a right to access personal information pertaining to themselves, held by the Club on request, unless one of the exceptions under the legislation will apply.
- If a member establishes that information held is not accurate, complete or up to date, then reasonable steps will be taken to correct the information.
- The General Manager of the Club will be the designated person to manage the Privacy Policy. If members have any complaints or concerns about privacy matters, they should contact the General Manager. It is understood members will be able to contact the Privacy Commissioner in regard to any matter.
