Annual Subscriptions - Pay by Instalment Plan Application for 2018

Available to 7 & 6 Day, Intermediate and Senior 7 & 6 Day Members only

Green Acres Golf Club offers an instalment option to 7 and 6 day members for the payment of Annual Subscriptions via Direct Debit. Instalments will be charged over 9 months and include an annual account keeping fee.

Members who choose to pay their subscriptions by instalments, remain liable for the full Subscriptions.

Please note the instalment option applies to the Annual Subscription only, all other ancillary membership fees such as Golf Victoria affiliation, the personal insurance plan, locker fees, Golf Victoria magazine, competition fees, club storage, club house levy, electric buggy store as detailed on your renewal invoice (GST inclusive) will be charged in full with your first instalment to your nominated bank account via Direct Debit. The remaining Subscription instalments will be charged monthly to your nominated bank account via Direct Debit. The terms and conditions of the Instalment Plan are set out on the Direct Debit Request and the Pay by Instalment Service Agreement. *Please note that monthly House Accounts do not form part of this arrangement and will be invoiced separately and require payment by existing methods.

In the event that a Direct Debit payment is rejected by the Member's bank, the member will be non-financial and liable for any consequential rejection fees and charges. Security will be held in the form of a current credit card to allow the Club to charge payment in the event of a rejection. Members wishing to amend a Direct Debit arrangement must give the Club notice in writing, 14 days prior to the date of the next instalment, as detailed in the Service Agreement.

SUBSCRIPTION INSTALMENT OPTION

One ninth of your annual subscription plus all ancillary membership charges will be deducted from your nominated account on Monday 2nd April 2018. Eight additional payments equal to one ninth of your subscription inclusive of an account keeping fee will be debited from your nominated account via Direct Debit commencing 1st May and thereafter the first day of each month (or closest business day) up to and including 1st December 2018.

Pay by Instalment Service Agreement - 2018

General

1. In the interpretation of this agreement words importing any gender include any other gender, words importing the singular number include the plural number and vice versa; words importing persons include corporations and any covenant or agreement in the part of two or more persons shall be deemed to bind them jointly and severally.

Approval

The Members application shall not constitute a binding agreement between the parties until the application is accepted by Green Acres and a valid Direct Debit agreement received.

Payment

1. The Member agrees to the monthly instalments referred to by Direct Debit. Each monthly instalment is payable on the day in each successive month that corresponds to the date stated on the schedule in the agreement. If that date falls on a non-business day, the next business day immediately following that day shall be the date for payment of this instalment.
2. If a direct debit drawing is unsuccessful, Green Acres reserves the right to attempt to re-draw at such times as it determines. This redraw will be inclusive of dishonour fees. Your financial institution may charge you a fee where a drawing is unsuccessful.
3. Green Acres has by this agreement been approved to recover a rejected instalment payment by a charge to the Member credit card. The member shall be advised when this occurs, including all fees and charges.
4. Green Acres will levy an annual account keeping fee for this service.
5. GST is payable on each instalment, and inclusive of the instalment amount advised.
6. Instalments will be processed on the following dates:
 - Monday 2nd April 2018
 - Tuesday 1st May 2018
 - Friday 1st June 2018
 - Monday 2nd July 2018
 - Wednesday 1st August 2018
 - Monday 3rd September 2018
 - Monday 1st October 2018
 - Thursday 1st November 2018
 - Monday 3rd December 2018

Acknowledgement

1. Until repayment in full of the total amount repayable under the terms of the instalment plan by The Member, the Member shall remain a debtor of Green Acres for all unpaid money.
2. The Member has authorised Green Acres to immediately charge their credit card only in the event that a direct debit instalment fails, without reference to the member. The member will be advised of the action taken within 14 days.

Default

1. If default is made in the payment of any of the Monthly Instalments by any of the respective due dates, and payment could not be secured against the member credit card, the Member authorises and empowers Green Acres on their behalf to do acts and execute such documents as may be required to discontinue this Instalment Plan and The Member will be liable to pay immediately, or on demand any amounts outstanding (under the terms of this Instalment Plan, including fees and charges) to Green Acres, its agents or assignees.

2. The Member shall pay to Green Acres on demand all unpaid instalments plus expenses (including enforcement expenses), if any, subject to compliance by Green Acres with any applicable laws.
3. The Member shall have their playing rights immediately suspended on any default on this agreement until such time that all amounts due and payable have been received by the club.
4. The Member shall pay a late payment penalty fee of \$10 if any instalment payment is not made on time. Dishonoured payments also incur a fee of \$2.50.
5. The Member shall not be entitled to participate in the instalment program in the following fiscal year.

Our commitment to you,

Drawing arrangements:

- We will advise you, in writing, the details of Green Acres Golf Club Instalment Plan drawing arrangements including amount, frequency and commencement date.
- We will keep all information pertaining to your nominated account at the Financial Institution, private and confidential.

Your rights:

- You may terminate Green Acres Golf Club Plan drawing arrangements at any time by giving written notice directly to us, or through your nominated Financial Institution. Notice given to us should be received by us at least 14 business days prior to the due date.
- You may stop payment of a drawing under Green Acres Golf Club Instalment Plan by giving written notice directly to us, or through your nominated Financial Institution. Notice given to us should be received by us at least 14 business days prior to the due date. If a stop payment request is lodged, the full amount outstanding becomes immediately due and payable.
- Where you consider that a drawing has been initiated incorrectly [outside Green Acres Golf Club Instalment Plan arrangements] you may take the matter up directly with us, or lodge a Direct Debit Claim through your nominated Financial Institution.

Your responsibilities:

I agree that by signing this form

- I understand that I am signing up for the full twelve months of Membership, or part thereof, at Green Acres Golf Club in the category I have selected
- I understand that I am liable for the full payment of this Membership including any fees and charges stated on my invoice, and as prescribed by the Board
- I understand that should I have more than one forfeited payment that the full amount of the remaining Membership subscription money for the year shall be due at that time and you will not be permitted to participate in the Instalment plan the following year.
- I understand that should I default on payment of my obligated instalments and the Club is unable to settle the issue with me, that the Club shall have the option to approach a debt collection agency to recover the money, and that my credit rating may be affected by this action.
- It is my responsibility to ensure that sufficient funds are available in the nominated account to meet a drawing on its due date.
- It is my responsibility to ensure that the authorisation given to draw on the nominated account is identical to the account signing instruction held by the Financial Institution where the account is based.
- It is my responsibility to advise the Club if the account nominated by myself to receive Green Acres Golf Club Instalment Plan drawings is transferred or closed.
- I understand that by participating in this form of membership payment, I shall have all the same rights and privileges as any member, in the category I have elected to join or renewed in.
